#	Job Steps Once pigs reach other end, let the crew running the compressor know to shut compressor down, and start blowing down the line, through the vac-truck	Hazards Lack of Communication. Line under pressure. Equipment Failure. Pig Stuck.	•	Ensure good radio contact and keep all lines of communication open during bleed down. Eyes and Mind on task. Make sure to bleed from pig catcher side so pigs don't get sucked back. Proper PPE at all times. Ensure all connections are secure and of the proper pressure rating. Only required and qualified personal in the work area. Ensure vents are open on Vac truck when blowing down. Ensure all equipment being used is appropriate for the task and was designed for the intended use. Inspect hoses/couplers and use whip checks/cotter pins to secure hoses in case of failure.

12	Once pressure is out of line, open receiving closure cautiously and have a drip tray underneath of closure in case of excess fluid.
