Guidelines

Safe Work Practices (SWP's) are a set of guidelines on how to perform a specific task. They outline what is to be done in general terms and, because a particular task is not always done the same way, allow some flexibility in how the work is actually accomplished.

Canadian Plains Energy Services (CPES) will ensure that a set of SWP's, most applicable/critical to our business, are in place and available for supervisors and workers to review at the worksite. We will ensure that these SWP's meet or exceed all applicable legislation and/or industry standards.

Guidelines

- Create an inventory of SWP's that would typically be required for the business that CPES does. Prioritize the list in terms of most applicable/critical and assign a development team.
- Review SWP's frequently to ensure the practice meets the requirements of the job and applicable legislation.
- Managers, supervisors, and workers will be involved in the development and review process.
- SWP's that are specific to work being done will be available to all workers at the worksite and reviewed at Pre-Job Safety and Daily Tailgate meetings.
- All employees are required to follow the guidelines of applicable SWP's.
- Supervisors are required to ensure that all applicable SWP's are available for review at the worksite.
